TRAINING INFORMATION FOR YEAR 2017 PROSPECTIVE TRAINEES AND/OR TRANSFERS

REQUIREMENTS FOR ADMISSION TO THE TRAINING PROGRAM

- ◆ Complete and return the enclosed NVFOA MEMBERSHIP APPLICATION, and check payable to “NVFOA” for \$65.00
- ◆ NVFOA Application Fee (\$65.00) covers Year 2017 Annual Dues of \$25.00 and a one-time \$40.00 NVFOA Application Fee for new members to cover the cost of training materials.
- ◆ Conform to personal appearance requirements. In summary, this Association does not permit beards to be worn on the field. Mustaches must be neatly trimmed. Hair must not extend beyond the top of the shirt collar. Specific details of dress code and personal appearance requirements will be provided at the initial training session/orientation. Date and time to be determined.
- ◆ One of our initial meetings will be an “Orientation Session”. It is designed to provide you with a detailed overview about football officiating in Northern Virginia, possibly address your questions in considerable detail and alleviate any fears you may have about embarking on a football officiating career. Additionally, you will be given the opportunity to meet [usually one – on – one] with an experienced regular member or Training Committee member to have dialogue about the NVFOA’s expectations of you and what you should expect from the NVFOA.

GENERAL INFORMATION

- ◆ Experienced officials transferring-in from another Association are required to attend a minimum of one [1] season of training to learn NVFOA mechanics and demonstrate their knowledge of National Federation rules and on-field officiating skills.

Dear Prospective NVFOA Member:

Enclosed is information pertaining to membership in the Northern Virginia Football Officials Association, Inc. [NVFOA] and Virginia High School League, Inc. [VHSL].

The enclosed paperwork is specifically for officials who have at least one full year of experience working Varsity-level football games. All transfer officials must complete one year of trainee status for skills evaluation and to learn NVFOA mechanics. All applicants to NVFOA must complete the NVFOA Application. All transfer officials with at least one full year of Varsity-level experience must also fill out the top portion of the Transfer Referral Sheet and have it completed by the association which made your Varsity assignments. This referral form will be used to evaluate your appropriate placement into our training program. Failure to complete all three forms will result in your placement in the training program as a first-year trainee.

Please complete the application and return it with your personal check in the sum of \$65.00 directly to the "Office of the Commissioner" at the above address. Your personal check should be made payable to "NVFOA". Once you have been accepted into the NVFOA you will later be required to join the VHSL through an online registration program.

The Transfer Referral Sheet should be sent directly from your previous association to the Office of the Commissioner.

◆ New [inexperienced] officials can expect to work regularly in Youth League, Freshman and Junior Varsity scholastic games. New officials who have no previous experience will not be assigned to Varsity games during the first year of training.

EARNINGS

◆ Game fees for Youth Leagues start at \$35 per man, per game, usually in 2 or 3 game sets. Scholastic game fees range from \$58 to \$99 depending on the level [Freshman – Junior Varsity – Varsity], and the number of officials [three or four for sub-varsity games and four, five, six or seven for varsity games]. Electric Clock Operators [ECOs] are also paid positions.

◆ You will be provided a complete Fee Schedule before the season begins. [The Association deducts 11% from every official's game fees to defray Association operating expenses.]
